Joint EASO / EJTN Professional Development Webinar on Country of Origin Information (COI) for EU+ judicial trainers

The **European Asylum Support Office (EASO)** is an EU Agency, dedicated to advance the establishment of a Common European Asylum System. Under article 6 of its founding Regulation and through the Network of Courts and Tribunals, EASO is developing professional development materials and activities intended for members of EU+ courts and tribunals. The **European Judicial Training Network (EJTN)** is the principal platform and promoter for the training and exchange of knowledge of the European judiciary. EJTN develops training standards and curricula, coordinates judicial training exchanges and programmes, disseminates training expertise and promotes cooperation between EU judicial training institutions.

Pursuant to their mandate to support EU+ members of Courts and Tribunals, EASO and EJTN are jointly organising a **pilot webinar series** on *Country of Origin Information* aimed primarily for current or future judicial trainers on COI.

All sessions will include **presentations in English** and interaction with two judicial trainers, a judicial training methodology expert and EASO experts.


Interaction will be encouraged through polls, questions and case studies. The webinar will take place via the Cisco WebEx platform.

Judicial Experts

Barbara Simma

Judge, Federal Administrative Court, Austria



Barbara Simma was appointed an administrative judge at the Bundesverwaltungsgericht in Austria (court of 1st instance) in 2014 and adjudicates as a single judge among other competences appeals against decisions on applications for international protection. Before her appointment, she worked as an assistant lawyer at the European Court of Human Rights. Country of origin information played an important role already in her work at the ECtHR in the context of Rule 39 – requests, but also later as a judge in asylum matters. Barbara participated in the drafting of the JPG on COI and was a co-trainer in related trainings in Bulgaria (2018) and in Athens (2019). She further had the opportunity to take part in a Fact Finding Mission organised by the Austrian Staatendokumentation to Jordan and Lebanon in 2017.

Sampo Löf-Rezessy

Judge, Administrative Court of Turku, Finland

Sampo Löf-Rezessy is an administrative court judge at the Turku Administrative Court in Finland. In his current position, he is deciding asylum and immigration cases. Prior to his appointment in 2017 he was working as a judge and as a referendary at another first instance court in Finland. In addition, he has practiced law as an advocate for asylum seekers. Löf-Rezessy has acted as a trainer in several national trainings in asylum and COI related issues. He has also been involved in developing working methods in relation to use of COI in administrative courts of Turku and Helsinki.





Dijana MandićHead of Continuous Training Department of the Croatian Judicial Academy, Croatia

Dijana Mandić has had a strong background in training matters from the legal perspective since joining Judicial Academy of Croatia in 2010, having previously practiced law after graduating from the Law faculty of the University of Zagreb in 2005. She is currently a Head of the Continuous and Initial Training Department where she also manages in e-learning and judicial training methods. She is a member of the EJTN's Judicial Training Methods Working Group and a trainer in e-learning and judicial training methods. She has also contributed as an expert to several EU projects dealing with capacity building of judicial training institutions, training and professional development of judicial officials.

- Being a serving member of a court or tribunal and / or a current judicial trainer, working in the field of international protection.
