2021 EJTN was the second pandemic year, and the second year in which planning and execution of judicial training was a challenge. The essence of the European Judicial Training Network's (EJTN's) training activities is to build and deepen mutual trust by bringing together judges and prosecutors from all over Europe, to enable them to meet in a protected physical space to discuss legal and other issues face-to-face. We have been back with regular face-to-face training activities since September 2021, and I hope that face-to-face training activities will again become normal in 2022.

We have learned a lot over the last two years. We are not only offering more online activities planned from scratch. We shall also go on to react quickly whenever the pandemic so requires, and we shall also move all seminars into virtual space in the future whenever needed. The strong will of the EJTN members to continue, to adapt, to make the best of any situation is the reason why I can again proudly present a calendar of training activities for 2022. The calendar you are holding once again expresses the hope that we can implement most of our activities in the way in which we are used to doing so - in person. It simultaneously gives flexibility - as in 2021 - to hold all activities online. All seminars in 2022 are planned from scratch with an alternative online distance learning option.

As usual, the EJTN 2022 offering is designed to address the interests and needs of European judges, prosecutors, judicial trainees and trainers from across Europe regarding training on EU law, the Rule of Law, judgecraft, training methodologies, linguistics and societal issues. In addition, 2022 will bring something very new: a large number of our training activities will be open to court staff.

EJTN's activities are the outcome of the collective efforts of EJTN's Members, encompassing all national training institutions from all 27 EU Member States, including national court staff training providers, and the Academy of European Law (ERA), with the objective of shaping the future of European judiciaries. They are built on an extensive training needs analysis including an evaluation of past events. These needs are expressed by the EJTN's Members, participants of EJTN's activities, numerous partner organisations, including judicial networks and associations, as well as European institutions and EU Council Presidencies.

I am grateful to everyone involved in the development and implementation of the activities: EJTN Member institutions, Working Group Programmes and the members of its four Sub-Working Groups, members of the Judicial Training Methods Working Group and the Linguistics Working Group, and all their conveners, activity coordinators, experts and project managers of the EJTN Secretariat.

Please find here an overview of EJTN's extensive range of training activities, as well as information on how, when and where to apply. I encourage everyone to take part in the seminars presented, as well as other training opportunities and to further disseminate information about the EJTN's training activities.

This calendar also presents the EJTN's database of materials and resources, and an English language self-test. Reference is also made in the publication to the EJTN lunchtime webinars and the recently launched online conversation classes in five languages.

Please note that the EJTN flagship activity, the Exchange Programme, is not presented in this calendar.

Finally, I would like to express my thanks to the European Commission for its financial support of the EJTN that made it possible to offer such a wide range of judicial training opportunities.

#### FIRST PILOT PROJECT OF ONLINE CONVERSATIONAL CLASSES

The EJTN has completed the first pilot project of online conversational classes. The series of six 1-hour weekly online classes started in November 2021 and the EJTN will repeat the series in 2022. Participants will be able to join one of the ten classes offered in various languages: English, French, German, Italian and Spanish. Several classes are held in English, some for participants at an intermediate (B1) language level and some for those at an upper intermediate (B2) language level. French, German, Italian and Spanish classes are intended for participants at an upper-intermediate (B2) language level.

The series helps participants improve their speech skills in the target language while also learning important legal terminology. Each class consists of 8–10 participants to maximise interaction between them. The project is conceived to improve the legal language skills of the participants and therefore prepare them for participation in any of the EJTN's numerous activities.

The next series of classes will be held in 2022. The exact dates will be announced in due course.

### 1H LUNCHTIME WEBINARS

EJTN reacted in 2020 to the coronavirus crisis with a series of short webinars in the 1 topic/1 expert/1 hour format. The topics were in line with the prevailing crisis and were well received by the EU judiciary. The series continued in 2021 with new topics related to the various areas. The popularity of the 1h Lunchtime

webinars has resulted in their continuation in 2022 with topics from the various portfolios and in the same format. In order to participate, potential attendees will register through the OSP platform; registration will be open to all interested candidates.




An online English language level test is available on the EJTN website: <a href="learning.ejtn.eu/login">learning.ejtn.eu/login</a>

The test has 50 questions testing grammar and vocabulary. Participants have a time limit of 45 minutes to complete the test. After completing the test, each participant receives a certificate from the system with the level attained. Interested candidates can repeat the test after one year.
