Objective

Key topics

- *Ex ante* v. *ex post* regulation: are there markets where competition is becoming sufficiently effective to give way to a normal competition law approach?
- The standard of review to be applied to the situations envisaged in Article 4 of the Framework Directive
- How national courts deal with: (i) the use of confidential documents, (ii) independent experts
- Admitting evidence not considered in the national regulatory authority decision
- Handling appeals from alternative dispute resolution decisions
- Managing large files and complex proceedings: what can be learned from the experiences in different Member States
- Relationship between European law and national law
- The Connected Continent legislative package
