Training event: "EU Competition Enforcement"

For the attention of: Financial and economic crimes investigators (law enforcement officers, public prosecutors, investigative judges, and their advisors/associates)

The training events are organised under the "Single Market Programme" (SMP-DGCOMP-2023-NCNE-IBA), implemented by the European Judicial Training Network (EJTN) with financial support from the European Commission's Directorate-General for Competition (DG COMP).

Targeted at judicial and law enforcement professionals handling financial and economic crime investigations, the trainings aim to improve the detection and prosecution of anti-competitive infringements across the EU. They seek to enhance the role of professionals who, while not directly responsible for competition enforcement, can support competition enforcement authorities at both European and national levels by sharing relevant information and evidence.

## TARGET AUDIENCE

- The target audience of the training are law enforcement officers, public prosecutors and investigative judges (incl. their advisors/associates) managing or conducting investigative activities in economic and financial matters as their core daily tasks.
- The **2** study visits are reserved for senior judicial or law enforcement professionals, based on their official position and/or professional experience. For example:
  - Heads or deputy heads of financial and economic crimes units (public prosecution and law enforcement offices).
  - Public prosecutors and law enforcement officers who are supervising other colleagues in the field of financial and economic crimes investigations.
  - Investigative judges or public prosecutors with 4+ years of work experience in financial and economic crimes investigations.
  - Investigative judges or public prosecutors with 10+ years of work experience in the judiciary, who are currently conducting financial and economic crime investigations.

#### **APPLICATION PROCEDURE:**

- Applications must include a completed Registration Form (attached).

#### **FINANCIAL CONDITIONS**

- Once officially invited by EJTN, participants are responsible for arranging their own travel and accommodation.
- Reimbursement of travel, accommodation, and subsistence costs will be provided after the event.
- Participants receive a fixed lump sum based on the location of their office and the event venue.
- No proof of actual expenses is required—boarding passes, invoices, and receipts do not need to be submitted.
